2. During the Financial Proposal Opening Meeting held on October 21, 2024, the total quoted prices were read aloud and recorded. As the mode of procurement is based on the lowest evaluated bid, it was noted that only one bid was received for LOT-1 from M/s Communicaid Systems, with a total cost amounting to **PKR 3,790,160/- (inclusive of all applicable taxes)**. The committee is of the view that since the received bid is within the ambit of RUDA's estimated cost and, furthermore, in accordance with regulation 44 of the amended RUDA Procurement Regulations 2022, a single complying bid is acceptable, and the competent authority may award the contract to the bidder. Consequently, the committee recommends awarding the contract for LOT-1 to **M/s Communicaid Systems**.
3. If approved, the evaluation report will be uploaded for a ten-day period in accordance with Regulation 40 of the RUDA Procurement Regulations 2022 on the Authority's website.
