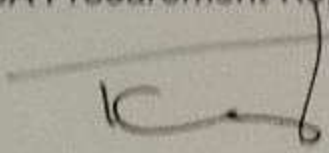

The item-wise rates were multiplied with the total quantity mentioned in the tender document and the final rates were compared with the bids submitted. As the mode of procurement was of lowest evaluated bid, but since only one bidder "M/s Computer Tips" has participated in the bidding process and as per Regulation 44 of the RUDA Procurement Regulations 2022 (amended), a single complying bid is acceptable, and the authority may award the contract to the bidder.

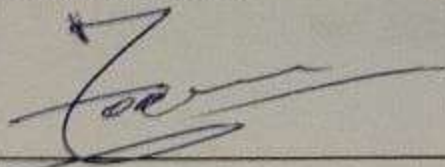
The total amount involved for procurement of IT Equipment/Hardware is **PKR 65,246,025/-**

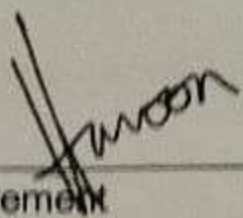

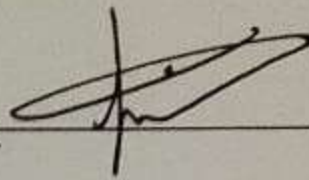

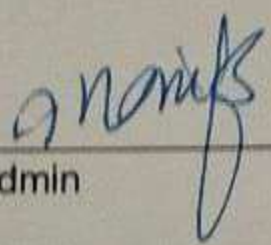
