1. Opening and Evaluation of Financial Proposals:

During the Financial Proposal Opening Meeting held on February 04, 2025, the quoted total prices were publicly announced and recorded. As the procurement process followed the lowest evaluated bid method, it is important to note that only one firm successfully passed the technical evaluation for LOT # 1 and for LOT # 4.

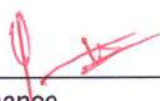
