REQUEST FOR PROPOSALS (RFP) WASTE TO ENERGY PROJECT IN LAHORE





Ravi Urban Development Authority ("RUDA"), intends to collaborate with potential partners in establishing a Waste-to-Energy Power Plant in the vicinity of its jurisdiction. The project is part of a comprehensive waste management strategy in compliance with circular economy concept to facilitate long-term solid waste management.

RUDA is already in receipt of an Unsolicited Proposal and having satisfied itself of the same, a Request for Proposal "("RFP") is floated on competitive basis in compliance with the Ravi Urban Development Authority (Public Private Partnership) Regulations, 2020 (the "Regulations") including but not limited to Regulation 17 (Unsolicited Proposal), for seeking bids to enter into a Public Private Partnership ("PPP") with RUDA for establishing and operating 40 MW (approximately) Waste to Energy Power Project in Lahore through private sector investment as an Independent Power Producer (IPP) in accordance with relevant policies and regulations.

The detailed description of works and responsibilities will be provided in the RFP and the concession agreement to be entered into with the successful bidder. Briefly:

RUDA WILL PROVIDE

- The waste required for the pro-
- · Land for the establishment of the project; and
- Facilitation and support, to the extent possible, in obtaining relevant approvals from the Government and other authorities.

The private party shall be responsible for undertaking the project for the entirety of its life. This would include without limitation:

- Obtaining requisite approvals in the form of Letter of Intent and Letter of Support, etc.;
- · Obtaining generation license and tariff;
- Design, engineering and establishment/construction of the plant;
- . Operation and maintenance of the plant; and
- Entering into appropriate agreements for the sale of electric power generated by the plant.
- In addition, the private party will also be responsible to make payment to RUDA as detailed in the concession agreement.

RFP INVITATION

This RFP invitation is open to all national and foreign companies/IV which have sound experience in the relevant field. Interested parties are requested to submit their Proposals against the RFP to be purchased from the office of the undersigned:

- interested companies may procure RFP document against payment of PKR 50,000 (USD \$ 281) by depositing non-refundable pay order in the name of Ravi Urban Development Authority (RUDA).
 Each Proposal will be evaluated on the basis of the evaluation criteria provided in the RFP and the Party obtaining
- highest Qualifying Score will be entitled to form PPP with RUDA for the development of Waste to Energy Power project subject to RUDA's acceptance in terms of the Regulations. Proposals must reach in a single sealed package containing three separate sealed envelopes marked as "FINANCIAL
- PROPOSAL, "TECHNICAL PROPOSAL" and "PRE-QUALIFICATION" (Single Stage, Three Envelope Bidding Procedure) by 10th February 2022, not later than 1500 hrs. (Pakistan Standard Time) at the address provided below:
